APPROVAL OF AGENDA

Mitigation assessments and new badges were added to the agenda. Jody moved to approve the amended agenda; Milo seconded. Passed unanimously.

APPROVAL OF MINUTES OF PREVIOUS MEETING

An update to the minutes from the April 2023 minutes was noted. Mark made a motion to approve the amended April 2023 minutes, Craig seconded. Passed unanimously.

INFORMATION ITEMS

Equipment

- Boat shed The Water and Sewer board has approved the location and construction of the boat shed pending a review of the exact location to determine if the shed is entirely on Water and Sewer property. Once we receive the approval letter from Water and Sewer, we will order the shed and begin construction. If we order the shed immediately it will be delivered in mid-July.
- Brush 1 the port-a-tank holder has been installed, the fire extinguisher has been mounted and a cracked valve has also been replaced.
- Engine 1 the water fire extinguishers have been mounted in Engine.
- Tender 1 fill level gauge. The fill gauge has been replaced and calibrated and Tender 1 is fully operational. The gauge turns red at a quarter tank.

Operations

- Beaver Meadows location identifiers Doug stated that this will be resolved by our next business meeting.
- Parking lines and handicapped parking space This project is almost complete, additional paint had to be ordered.

Training

- CLVFD Thursday 6/1 at 1800 Training this month will focus on Wildland 2. We will check our Wildland packs and make sure they are ready to go and review basics on the vehicles.

DISCUSSION TOPICS

Personnel

• Jim and Pam Liebl were introduced as potential new SDRs. They are neighbors of Jon and Sue Gessert. Jim attended the last SDR training meeting and they both will get together with Jody after approval to begin training.

Communications

Evan discussed our radio communications and reviewed the channels we use for incidents — LCFIRE and LCEMS. Use Channel 4 when available for radio-to-radio communication. It's a good idea to think about what you are going to say before you get on the radio. Whoever is first on scene should declare IC and establish that verbally with 900. Don't be afraid to assume command, you can hand off IC when others arrive. Be sure to close the communication loop. We do this well and have received positive input from dispatch. When an incident begins, it's important to turn on your radio first. Dispatch relays additional information once they hear a response. Be sure not to interrupt when responding and wait until you are in your vehicle before coding up. The IC should communicate directly with the lead SDR and only the IC and possibly the lead SDR should be communicating with 900.

Community Outreach

Events will include short presentations on fire and wildlife safety from 10:00 to 12:00, lunch (hot dogs), and booths with handouts. Flags will be raised and then lowered to half-staff until noon. At that time, they will be raised back up.

Operations

The fire department offers this service at no charge, whereas the county charges a fee. We can make recommendations to homeowners, but we cannot sign off on any insurance forms due to liability.

Safety

Thunderstorm awareness and safety

Thunderstorms, including downbursts, cause significant hazards for wildland firefighters. Downbursts can cause extreme fire behavior and lightning. When thunderstorm development is likely, lookouts should be aware of the signs.

Approaching thunderstorms may be noted by a sudden reverse in wind direction, a noticeable rise in wind speed, and a sharp drop in temperature. Rain, hail, and lightning occur only in the mature stage of a thunderstorm.

Situational Awareness: Sound waves move at different rates based on atmospheric conditions. Take the storm precautions below as soon as you hear thunder, not when the storm is upon you. Do not resume work in exposed areas until 30 minutes after storm activity has passed.

Hazard Control:

- o Take shelter in a vehicle or building if possible.
- If outdoors, find a low spot away from tall trees, wire fences, utility lines and other elevated conductive objects. Make sure the place you pick isn't subject to flooding.
- o If in the woods, move to an area with shorter trees.
- o If only isolated trees are nearby, keep your distance twice the tree height.
- o If in open country, crouch low with feet together, minimizing contact with the ground. You can use a pack to sit on, but never lie on the ground.
- If you feel your skin tingle or your hair stand on end, immediately crouch low to the ground.
 Make yourself the smallest possible target and minimize your contact with the ground.
- Don't group together.
- o Don't stay on ridge tops, in wide open areas, or near ledges or rock outcroppings.
- o Don't operate landline telephones, machinery, or electric motors.
- o Don't handle metal hand tools or flammable materials in open containers.

As the Membership Desires

- Doug stated that we will initiate extra, optional training a couple of times a month. The first optional training day is set for Wednesday, May 31, at 18:00. The focus will be on drafting.
- It was noted that the "y" is missing from our fire sign on Tami. Doug stated that a replacement letter has been ordered and once we receive it he will repair the sign.
- A reminder to go to the office and get your new ID cards. Our current ones expire on 6/30/23.
- Mark has designed a training checklist that covers everything, drafting, PPE, apparatus, etc. It helps give direction to new members and lets new member know what the expectations are.
- Anne stated the siren #3001 was not working but Alex repaired it and the siren is operational again.
- Susan received word that Water and Sewer is on board with the boat shed placement and she will get a letter out to the Road & Rec committee tomorrow.
- Members voted on new SDRs Pam and Jim Liebl. Result approved.
- Members voted on Melanie becoming a full-time member. Result approved.
