INCIDENT REPORTS FOR 2020

January 1, afternoon -- Incident #1 -- medical call at Beaver Meadows -- CLVFD emergency responders provided patient assessment and care for a patient who ultimately decided to refuse ambulance services.

January 24, afternoon -- Incident #2 -- medical call in Filing 7 -- CLVFD emergency responders provided patient assessment and care while special duty responders provided lead-in for the Red Feather Lakes ambulance and set up traffic control to assist emergency vehicles to safely reach and leave the scene.

January 30, morning -- Incident #3 -- medical call at Basecamp -- CLVFD emergency responders provided patient assessment and care while special duty responders provided lead-in for the Red Feather Lakes ambulance and set up traffic control to assist emergency vehicles to safely reach and leave the scene.

February 2, evening -- Incident #4 -- medical call in Filing 7 -- CLVFD emergency responders provided patient assessment and care while special duty responders provided lead-in for the Red Feather Lakes ambulance and set up traffic control to assist emergency vehicles to safely reach and leave the scene.

February 22, evening -- Incident #5 -- medical call at Basecamp -- CLVFD emergency responders provided patient assessment and care while special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control around the landing zone set up by firefighters for MedEvac.

February 23, evening -- Incident #6 -- medical call in Filing 8 -- CLVFD emergency responders provided patient assessment and care while special duty responders provided lead-in for the Red Feather Lakes ambulance and set up traffic control around the scene so responders could arrive and leave safely.

February 24, evening -- Incident #7 -- fire in Filing 12 -- CLVFD firefighters responded to reports of a chimney fire in the 12th Filing. Upon arrival, responders were able to determine that the

overgrowth of the fire in the wood stove had not, in fact, caught the chimney on fire. All responders stood down once fire in the stove was damped down to controllable levels.

March 4, evening -- Incident #8 -- medical call in Filing 8 -- CLVFD emergency responders provided patient assessment and care while special duty responders and firefighters provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control around the scene so responders could arrive and leave safely.

March 5, afternoon -- Incident #9 -- medical call in Filing 8 -- CLVFD emergency responders provided patient assessment and care while special duty responders and firefighters provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control around the scene so responders could arrive and leave safely.

March 6, afternoon -- Incident #10 -- medical call in Filing 8 -- CLVFD emergency responders provided patient assessment and care while special duty responders and firefighters provided lead-in for the Red Feather Lakes ambulance and set up traffic control around the scene so responders could arrive and leave safely.

March 7, evening -- Incident #11 -- medical call in Filing 8 -- CLVFD emergency responders provided patient assessment and care while firefighters established a landing zone for the Lifeline helicopter. Special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control around both the scene and the landing zone, so responders could arrive and leave safely.

March 28, afternoon -- Incident #12 -- medical call in Filing 1 -- CLVFD emergency responders provided patient assessment and care while special duty responders provided lead-in for the Red Feather Lakes ambulance and set up traffic control around the scene so responders could arrive and leave safely.

May 6, morning -- Incident #13 -- medical call in Filing 13 -- CLVFD emergency responders provided patient assessment and care while special duty responders provided lead-in for the Red Feather Lakes and UCHealth ambulances and set up traffic control around the scene so responders could arrive and leave safely.

May 21, afternoon -- Incident #14 -- medical call at the fire station -- CLVFD emergency responders provided patient assessment and care while firefighters established a landing zone for the Lifeline helicopter. Special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control around both the scene and the landing zone, so responders could arrive and leave safely.

May 22, evening -- Incident #15 -- medical call in Filing 14 -- CLVFD emergency responders provided patient assessment and care while special duty responders provided lead-in for the Red Feather Lakes ambulance and set up traffic control around the scene so responders could arrive and leave safely.

May 23, morning -- Incident #16 -- medical call in Filing 15 -- CLVFD emergency responders provided patient assessment and care while special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control around the scene so responders could arrive and leave safely.

May 29, morning -- Incident #17 -- vehicle breakdown on 73C -- CLVFD firefighters and Special Duty Responders set up traffic control around a vehicle that had broken down on a blind corner on 73C so traffic could safely pass.

June 1, afternoon -- Incident #18 -- wildfire at Creedmore Lakes -- CLVFD firefighters responded to an escaped campfire in the area of Creedmore Lakes and worked with firefighters from Red Feather Lakes VFD to extinguish it.

June 9, evening -- Incident #19 -- medical call in Filing 1 -- CLVFD emergency responders provided patient assessment and care for a patient who ultimately refused transport.

June 10, afternoon -- Incident #20 -- medical call in Beaver Meadows -- CLVFD emergency responders provided patient assessment and care while special duty responders provided leadin for the Red Feather Lakes and UC Health ambulances and set up traffic control around the scene so responders could arrive and leave safely. **June 12, morning -- Incident #21** -- smoke report near North Ottawa -- CLVFD firefighters and special duty responders fanned out to find the source of smoke reported on the north side of the lake. After some effort, it was tracked to an approved campfire and all responders stood down.

June 13, morning -- Incident #22 -- medical call at the Water & Sewer Building -- CLVFD emergency responders provided patient assessment and care while special duty responders provided traffic control around the scene so responders could arrive and leave safely.

June 16, afternoon -- Incident #23 -- wildfire at Lost Lake -- CLVFD firefighters responded to a wildfire in the area of Lost Lake and worked with firefighters from Red Feather Lakes VFD to extinguish it.

June 16, afternoon -- Incident #24 -- medical call at Lost Lake -- While CLVFD firefighters were responding to an escaped campfire in the area of Lost Lake, one of the firefighters had a medical emergency that EMS responders assisted with.

June 27, evening -- Incident #25 -- medical call in Filing 15 -- CLVFD emergency responders provided patient assessment and care while special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control around the scene so responders could arrive and leave safely.

June 29, afternoon -- Incident #26 -- hazmat call at Crystal Lake -- CLVFD firefighters responded to a report of a construction vehicle that had slid into the lake. The vehicle was pulled out before responders arrived. Firefighters cleaned up the oil spill in the lake while special duty responders set up traffic control around the scene so responders could arrive and leave safely.

June 29, evening -- Incident #27 -- smoke report on Black Mountain -- CLVFD firefighters responded to a report of smoke sighted partway up the east side of Black Mountain. After some searching, this was tracked to an approved firepit in which some green firewood was being burned. All responders stood down.

July 4, evening -- Incident #28 -- mutual aid to Red Feather VFD -- CLVFD personnel responded to assist Red Feather Lakes VFD with traffic control around a motor vehicle accident on Deadman Road.

July 8, afternoon -- Incident #29 -- potential water rescue in Crystal Lakes -- CLVFD personnel responded to a report of an empty boat floating in Crystal Lake. Responders made contact with the boat's owner and determined that it had broken loose from its mooring and no one had been capsized into the lake.

July 10, morning -- Incident #30 -- medical call in Filing 10 -- CLVFD emergency responders provided patient assessment and care while firefighters set up a landing zone for the Lifeline helicopter and special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control around the landing zone and the scene so responders could arrive and leave safely.

July 11, evening -- Incident #31 -- medical call at Lost Lake -- CLVFD emergency responders provided patient assessment and care for a patient who ultimately refused transport.

July 19, morning -- Incident #32 -- medical call in Filing 7 -- CLVFD emergency responders provided patient assessment and care while special duty responders provided lead-in for the Red Feather Lakes ambulance and set up traffic control around the scene so responders could arrive and leave safely.

July 30, evening -- Incident #34 (dispatch accidentally skipped #33) -- medical call in Filing 9 --CLVFD emergency responders provided patient assessment and care while special duty responders provided lead-in for the Red Feather Lakes ambulance and set up traffic control around the scene so responders could arrive and leave safely.

August 3, afternoon -- Incident #35 -- medical call at fire station -- CLVFD emergency responders provided patient assessment and care for a patient who ultimately refused transport.

August 3, evening -- Incident #36 -- carbon monoxide call in Filing 11 -- CLVFD firefighters responded to assist a homeowner with a chirping CO alarm, determined that there was no CO

in the house, replaced the batteries in the alarm, and ultimately determined it was faulty and needed to be replaced.

August 5, afternoon -- Incident #37 -- carbon monoxide call in Filing 11 -- CLVFD firefighters responded to assist a homeowner with a chirping CO alarm, determined that there was no CO in the house, replaced the batteries in the alarm, and recommended replacement of all CO monitor and smoke alarm batteries to set a baseline for future maintenance.

August 5, evening -- Incident #38 -- medical call at Hohnholz Lake -- CLVFD emergency responders were paged out for an injury at one of the Hohnholz Lakes, which are well outside the district to the northwest. It was ultimately determined, in consultation with Larimer Dispatch, that Wyoming responders had much quicker and better access, and all Crystal responders stood down.

August 7, afternoon -- Incident #39 -- medical call at Water & Sewer building -- CLVFD emergency responders provided patient assessment and care while special duty responders provided lead-in for the Red Feather Lakes ambulance and set up traffic control around the scene so responders could arrive and leave safely.

August 13, evening -- Incident #40 -- mutual aid at Deadman Road -- At the request of Larimer County Emergency Services, CLVFD special duty responders handled traffic control at the intersection of 74E and Deadman Road while the Deadman Road area was being evacuated. They were tasked with preventing access into the Deadman area so evacuees could more easily leave.

August 21, afternoon -- Incident #41 -- ATV accident in Filing 11 -- CLVFD emergency responders provided patient assessment and care while firefighters set up a landing zone for the Lifeline helicopter and special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control around the accident scene and the landing zone.

August 29, morning -- Incident #42 – smoke report northeast of Crystal -- CLVFD firefighters joined RFLVFD firefighters in searching for the source of smoke reported in the Kelly's Corner area. This was ultimately tracked to an enclosed cookstove that was permissible under the current fire ban, and all responders stood down.

September 9, midnight -- Incident #43 -- medical call in Filing 12 -- CLVFD emergency responders provided patient assessment and care while firefighters provided lead-in for the Red Feather Lakes ambulance and set up traffic control around the scene so responders could arrive and leave safely.

September 13, morning -- Incident #44 -- medical call in Filing 4 -- CLVFD emergency responders provided patient assessment and care while special duty responders provided leadin for the Red Feather Lakes ambulance and firefighters set up traffic control around the scene so responders could arrive and leave safely.

September 20, all day -- Incident #45 – Cameron Peak Fire – The CLVFD Task Force (consisting of our structure engine, brush truck, water tender, and squad) responded to assist the area strike team in patrolling for spotfires along 74E and 73C, doing structure preparation/mitigation ahead of the fire, and refilling engines and portatanks with water as needed.

September 21, all day -- Incident #46 – Cameron Peak Fire – The CLVFD Task Force (consisting of our structure engine, brush truck, water tender, and squad) responded to assist the area strike team in patrolling for spotfires along 74E and 73C, doing structure preparation/mitigation ahead of the fire, and refilling engines and portatanks with water as needed.

September 24, afternoon -- Incident #47 -- medical call in Pearl Creek area -- CLVFD emergency responders provided patient assessment and care while firefighters provided lead-in for the Red Feather Lakes ambulance and set up a landing zone for the MedEvac helicopter.

September 26, all day -- Incident #48 – Cameron Peak Fire – The CLVFD Task Force (consisting of our structure engine, brush truck, water tender, and squad) responded to assist the area strike team in patrolling for spotfires along 74E and 73C, doing structure preparation/mitigation ahead of the fire, and refilling engines and portatanks with water as needed. September 27, all day -- Incident #49 – Cameron Peak Fire – The CLVFD Task Force (consisting of our structure engine, brush truck, water tender, and squad) responded to assist the area strike team in patrolling for spotfires along 74E and 73C, doing structure preparation/mitigation ahead of the fire, and refilling engines and portatanks with water as needed.

September 30, all day -- Incident #50 – Cameron Peak Fire – The CLVFD Task Force (consisting of our structure engine, brush truck, water tender, and squad) performed structure mitigation along the south and west edges of Filings 1, 7, 9, and 14.

October 1, all day -- Incident #51 – Cameron Peak Fire – The CLVFD Task Force (consisting of our structure engine, brush truck, water tender, and squad) performed structure mitigation along the south and west edges of Filings 1, 7, 9, and 14.

October 14, starting pre-dawn -- Incident #52 – Cameron Peak Fire – The CLVFD Task Force (consisting of our structure engine, brush truck, water tender, and squad) responded to assist Red Feather Lakes VFD in fighting a spot fire that flared up near Bellaire Lake.

October 19, afternoon -- Incident #53 – fire alarm in Filing 11 – CLVFD firefighters responded to a report of a possible structure fire in the 11th Filing. The property owner's remote sensors were reporting a significant increase in temperature inside the house. Responders were unable to locate any sign of a fire and reported the sensors must be faulty.

October 26, morning -- Incident #55 (Dispatch accidentally skipped **#54**) – CO alarm in Filing 9 – CLVFD firefighters responded to a report of a carbon monoxide alarm going off. Responders stood down after checking for carbon monoxide with fire department equipment.

October 29, morning -- Incident #56 -- medical call in Filing 5 -- CLVFD emergency responders provided patient assessment and care while special duty responders provided lead-in for the Red Feather Lakes and UCH ambulances.

November 1, afternoon -- Incident #57 – MVA on Osage Trail – CLVFD

firefighters responded to a report of a vehicle off Osage Trail and in danger of sliding down a steep embankment. Firefighters secured the vehicle so the driver could exit safely and called a tow company to safely retrieve the vehicle.

November 7, evening -- Incident #58 --- mutual aid to Red Feather VFD --- CLVFD firefighters were nearby when Red Feather Lakes VFD received a call regarding a carbon monoxide detector going off in a residence and responded to assist.

November 17, afternoon -- Incident #59 --- fire on Blackfoot Road --- CLVFD firefighters responded to a report of a dumpster on fire after hot ashes had been dumped into it. Firefighters extinguished the fire, then stood down. DO NOT dispose of hot ashes in a dumpster, the Crystal Lakes compactor, or in any other flammable area. Ashes should be kept in a non-flammable container for several days to ensure they're completely cold before being disposed of.

November 28, evening -- Incident #60 --- gas leak in Filing 13 --- CLVFD firefighters responded to a report of the odor of gas coming from a property in the 13th Filing. Responders confirmed that there was a strong odor of propane and determined that there was a leak in the line coming from a recently-filled propane tank. They were able to shut off the tank and stop the leak and informed the homeowner that they would need to get their propane company out to fix the damaged line.

December 9, noon -- Incident #61 -- medical call at Beaver Meadows -- CLVFD emergency responders provided patient assessment and care while Special Duty Responders provided lead-in for the Red Feather Lakes ambulance and set up traffic control around the scene so responders could arrive and leave safely.

December 28, noon -- Incident #62 -- motor vehicle accident at Beaver Meadows -- CLVFD emergency responders provided patient assessment and care for those injured in the MVA while Special Duty Responders provided lead-in for the Red Feather Lakes ambulance and set up traffic control around the scene so responders could arrive and leave safely.

December 28, noon -- Incident #63 -- medical call in Filing 3 -- CLVFD emergency responders provided patient assessment and care while Special Duty Responders provided lead-in for the Red Feather Lakes ambulance and set up traffic control around the scene so responders could arrive and leave safely.
