# **Equipment**

- <u>Boat Shed</u>: Doug installed some shelves and a closet rod in the Boat Shed. Some items have been moved from the Support apparatus to the boat shed. Please check out the compartments in Support to familiarize yourself with its current contents. Items moved to the shed include:
  - Several PFDs (personal flotation devices)
  - One ice rescue suit
  - Long rescue surfboard
  - Rope reel
  - One rope throw bag
- Apparatus maintenance:
  - We will start taking apparatus to Beck's Automotive for scheduled maintenance starting this next month.
- Squad 1 and Support:
  - We are planning to get rid of Support and convert current Squad 1 into our support/rescue apparatus. As a result, equipment locations will change. Mike, Jay, and Evan have been working on this and we will provide updates on equipment locations as they occur. We are looking at purchasing a different vehicle to serve as Squad 1.
- <u>Siren batteries and charger testing</u>: Reach out to Jay if you're able to help.
- Station:
  - Main bay lights: have been rewired for reliable operation. The over-locker lights now come on with lights over Brush 1 bay.
  - Folding mezzanine stairway: Scheduled delivery: Monday, 04/29 between 9-5. A few volunteers needed!
