1. Department Activity since the last board meeting

3. TRAINING:

Department trainings:

- August's training was switched with the July topic (Structure 2). During this training, firefighters engaged a mock structure fire scenario at a location in Red Feather's District. Both RFLVFD and CLVFD firefighters participated in this training, as well as SDRs from CLVFD.
- September training is Beaver Meadows Scenario.
- A Crystal Lakes Dam Evacuation training WILL be scheduled this fall. Details forthcoming.

Outside trainings:

- Nothing right now. Tony Falbo with Poudre Canyon FPD indicated they would be holding some trainings soon and inviting the mountain departments to join them. Still no word on that.

- Jim is working on an equipment acquisition opportunity through the DFPC to acquire higher-quality PPE, such as leather structure firefighting boots and additional/upgraded wildland PPE for new/returning members.

- The FD has been working with Raina Eschelmann from Larimer County Emergency Services to standardize an HIZ assessment tool for use by both the County and the Department. Assistant Chief Kelly is in communication with Raina, and they have already held one training for Department members interested in becoming HIZ assessors. A second training has yet to be scheduled with Raina for those department members interested in becoming assessors, but who were unable to attend the first training.

6. EQUIPMENT

- Engine 1 electrical problem seems to be resolved. Thank you, Alex and Mark!
- The siren stopped working on Brush 2. Emergency lights are still operational. I have no status update.
- Brush 1 is subject to a manufacturer recall that currently has no available solution. It is safe to drive, but may be unsafe to keep inside the station.
