

## INCIDENT REPORTS FOR 2022

**January 7, morning -- Incident #1** -- medical call in Filing 11 -- CLVFD emergency responders provided patient assessment and care while Special Duty Responders led in the Red Feather Lakes ambulance and, with firefighter assistance, set up traffic control around the area where the Red Feather and UC Health ambulances rendezvoused to hand off the patient.

**January 10, afternoon -- Incident #2** -- medical call in Filing 8 -- CLVFD emergency responders provided patient assessment and care while firefighters prepared to set up a landing zone for the Lifeline helicopter (called off once it was determined it wasn't needed) and Special Duty Responders led in the Red Feather Lakes and UC Health ambulances.

**January 29, morning -- Incident #3** -- medical call at Beaver Meadows -- CLVFD emergency responders provided patient assessment and care while Special Duty Responders established traffic control around the scene and led in the Red Feather Lakes ambulance.

**January 31, afternoon -- Incident #4** -- powerlines down in Filing 12 -- CLVFD firefighters and Special Duty Responders established traffic control around downed powerlines near the intersection of Ottawa and Oneida during a windstorm. Firefighters prepared to extinguish any fires caused by sparking wires and all responders kept people from entering the danger zone until PVREA could arrive to fix the lines.

**February 9, morning -- Incident #5** -- mutual aid to RFLVFD -- CLVFD firefighters responded to assist Red Feather Lakes VFD, which was called out to a fire alarm at Morningstar Church. Everyone stood down when it was determined the alarm was due to a mechanical failure.

**February 12, evening -- Incident #6** -- medical call in Filing 11 -- CLVFD emergency responders provided patient assessment and care while Special Duty Responders led in the Red Feather Lakes ambulance.

**February 18, afternoon -- Incident #7** -- medical call at Beaver Meadows -- CLVFD emergency responders provided patient assessment and care while Special Duty Responders staged to lead in the Red Feather Lakes ambulance, which was called off before it arrived due to the patient deciding to go down by personal vehicle.

**February 26, morning -- Incident #8** -- medical call at Beaver Meadows -- CLVFD emergency responders provided patient assessment and care while Special Duty Responders led in the Red Feather Lakes ambulance and set up traffic control around the scene.

**March 8, night -- Incident #9** -- medical call in Filing 5 -- CLVFD emergency responders provided patient assessment and care while firefighters staged to establish a landing zone in case the helicopter was called and Special Duty Responders led the Red Feather Lakes ambulance to the scene.

**March 17, evening -- Incident #10** -- medical call in Filing 9 -- CLVFD emergency responders provided patient assessment and care while firefighters assisted with access to the scene (plowing part of the road to make it clearer) and Special Duty Responders led the Red Feather Lakes ambulance to the scene.

**April 6, evening -- Incident #11** -- medical call in Filing 9 -- CLVFD emergency responders provided patient assessment and care while firefighters responded to Red Feather Station to assist in establishing a landing zone for the helicopter and Special Duty Responders led the Red Feather Lakes ambulance to the scene.

**April 9, morning -- Incident #12** -- medical call in Filing 5 -- CLVFD emergency responders provided patient assessment and care while firefighters established a landing zone for the helicopter and Special Duty Responders led the Red Feather Lakes and UC Health ambulances to the scene.

**April 15, afternoon -- Incident #13** -- medical call in Filing 12 -- CLVFD emergency responders provided patient assessment and care while firefighters established a landing zone for the helicopter and Special Duty Responders led the Red Feather Lakes and UC Health ambulances to the scene.

**April 15, evening -- Incident #14** -- medical call in Red Feather -- CLVFD emergency responders assisted RFLVFD in providing assessment and care for a patient at Red Feather Station.

**April 15, afternoon -- Incident #15** -- medical call in Filing 1 -- CLVFD emergency responders provided patient assessment and care while firefighters staged to establish a landing zone in case the helicopter was called and Special Duty Responders led the Red Feather Lakes ambulance to the scene.

**April 26, afternoon -- Incident #16** -- medical call in Filing 12 -- CLVFD emergency responders provided patient assessment and care while firefighters

established a landing zone for the helicopter and Special Duty Responders led the Red Feather Lakes and UC Health ambulances to the scene.

**April 30, evening -- Incident #17** -- medical call at Crystal station -- CLVFD emergency responders provided patient assessment and care while firefighters established a landing zone for the helicopter (ultimately not needed). Special Duty Responders led the Red Feather Lakes ambulance to the scene and provided traffic control around the rendezvous point on 73C where the patient was transferred from the RF ambulance to the UC Health ambulance.

**May 17, evening -- Incident #18** -- medical call at RF station -- CLVFD emergency responders provided patient assessment and care for an injury that occurred during a joint training at Red Feather Lakes fire station.

**June 3, night -- Incident #20 (Dispatch accidentally skipped 19)** -- medical call in Filing 7 -- CLVFD emergency responders provided patient assessment and care while Special Duty Responders staged to lead the Red Feather Lakes ambulance to the scene. Ultimately, no further assistance was required and all responders stood down.

**June 6, afternoon -- Incident #21** -- medical call in Filing 10 -- CLVFD emergency responders provided patient assessment and care while firefighters established a landing zone for the helicopter and Special Duty Responders led the Red Feather Lakes and UC Health ambulances to the scene.

**June 18, evening -- Incident #22** -- medical call in Filing 7 -- CLVFD emergency responders provided patient assessment and care while Special Duty Responders led the Red Feather Lakes and UC Health ambulances to the scene.

**June 18, midnight -- Incident #23** -- mutual aid to RFLVFD -- CLVFD firefighters responded to assist Red Feather Lakes VFD with a motor vehicle accident on 74E, with Special Duty Responders setting up traffic control around the scene to keep responders safe.

**June 19, afternoon -- Incident #24** -- smoke report near Beaver Meadows -- CLVFD firefighters and Special Duty Responders answered a call about a column of smoke sighted near Beaver Meadows. Responders tracked the smoke to a legal campfire and stood down.

**June 24, morning -- Incident #25** -- medical call in Filing 3 -- CLVFD emergency responders provided patient assessment and care while Special Duty Responders led the Red Feather Lakes and UC Health ambulances to the scene.

**June 27, night -- Incident #26** -- unsafe campfire report near Kelly's Corner -  
- CLVFD firefighters joined RFLVFD firefighters in searching for a report of an  
unsafe campfire in the vicinity of Kelly's Corner. No fire was found and all  
responders stood down.

**July 3, evening -- Incident #27** -- medical call in Beaver Meadows -- CLVFD  
emergency responders provided patient assessment and care while firefighters  
established a landing zone for the helicopter and Special Duty Responders set up  
traffic control around the landing zone and led the Red Feather Lakes and UC  
Health ambulances to the scene.

**July 10, evening -- Incident #28** -- unsafe campfire report near Beaver  
Meadows -- CLVFD firefighters and Special Duty Responders answered a call  
about a large campfire sighted near Beaver Meadows. Responders tracked the  
smoke to a legal campfire and stood down.

**July 16, evening -- Incident #29** -- smoke report in Filing 1 -- CLVFD  
firefighters and Special Duty Responders answered a call about smoke sighted  
northwest of Crystal Lakes. Responders determined this was smoke coming in  
from large fires in neighboring states.

**July 17, afternoon -- Incident #31** (Dispatch accidentally skipped 30) --  
mutual aid to RFLVFD -- CLVFD firefighters responded to assist Red Feather  
Lakes VFD with a large structure fire near the Village. Special Duty Responders  
provided lead-in of responders from other mountain departments and traffic  
control to keep all responders safe. The fire was ultimately contained to two  
structures and the surrounding trees.

**July 24, evening -- Incident #32** -- medical call in Filing 8 -- CLVFD  
emergency responders provided patient assessment and care while Special Duty  
Responders led the Red Feather Lakes and UC Health ambulances to the scene.

**July 26, morning -- Incident #33** -- trailer fire in Beaver Meadows -- CLVFD  
firefighters responded to a trailer on fire in one of the Beaver Meadows  
campgrounds and called on Red Feather Lakes VFD to provide assistance in  
keeping the fire from spreading. Special Duty Responders provided lead-in of  
RFLVFD responders and traffic control to keep all responders safe. The fire was  
ultimately contained to the trailer and a few surrounding trees.

**July 29, evening -- Incident #34** -- mutual aid to RFLVFD -- CLVFD  
firefighters responded to assist Red Feather Lakes VFD with a motor vehicle  
accident on Deadman Road.

**August 6, morning -- Incident #35** -- smoke report south of Crystal Lake -- CLVFD personnel responded to the report of smoke sighted southwest of the big lake. After some searching, responders tracked it to a safe campfire and stood down.

**August 11, morning -- Incident #36** -- medical call in Filing 10 -- CLVFD emergency responders provided patient assessment and care while firefighters set up a landing zone for the helicopter and Special Duty Responders led in the Red Feather Lakes ambulance and set up traffic control around the landing zone.

**August 14, morning -- Incident #37** -- smoke report near 73C & Tiny Bob Road -- CLVFD firefighters responded to a smoke report and found an illegal slash burn. Resident was told to let the fire go out (it was in a legal firepit and would be safe if no more fuel was added to it) and advised about the county regulations regarding slash burns and responders stood down.

**August 14, evening -- Incident #38** -- wildland fire in Filing 2 -- CLVFD firefighters responded to a tree struck by lightning and burning on Beartrap Road. The tree was partially hollow and burning internally, and split dangerously by the lightning, so firefighters had to call in an expert sawyer to safely drop it so they could section it into pieces and cut it open to get the fire completely out. Special Duty Responders provided traffic control and lead-in for Red Feather units, who responded to assist in providing a constant water supply to keep the fire from spreading until it could be properly attacked. Firefighters returned the next morning to verify that there were no remaining hotspots that might flare up once the day warmed.

**August 20, evening -- Incident #39** -- illegal burn near Lost Lake -- CLVFD firefighters responded to a report of smoke and flames about a mile west of the intersection of 67J and 73C, joining RFLVFD firefighters in looking for the source of the fire. It was tracked to a property owner in that area illegally burning a large trash pit containing, among other things, large items of furniture. Firefighters extinguished the fire and advised the property owner about the county regulations against burning trash, then turned the scene over to law enforcement and stood down.

**August 25, morning -- Incident #40** -- medical call in Filing 14 -- CLVFD emergency responders provided patient assessment and care while firefighters responded to Red Feather station to assist in setting up a landing zone for the helicopter and Special Duty Responders provided lead-in and traffic control for the Red Feather Lakes ambulance.

**August 27, noon -- Incident #41** -- mutual aid to RFLVFD -- CLVFD firefighters responded to assist Red Feather Lakes VFD in rescuing a person who'd gotten stuck on a roof and was in danger of falling.

**September 3, afternoon -- Incident #42** -- medical call in Filing 7 -- CLVFD emergency responders provided patient assessment and care while firefighters stood by to set up a landing zone if a helicopter was needed and Special Duty Responders provided lead-in and traffic control for the Red Feather Lakes ambulance.

**September 5, afternoon -- Incident #43** -- smoke report south of Pearl Creek -- CLVFD firefighters responded to a report of smoke sighted a couple of miles south of the Pearl Creek area. After a lengthy search, responders were unable to spot any smoke and stood down.

**September 10, morning -- Incident #44** -- medical call in Filing 8 -- CLVFD emergency responders provided patient assessment and care while firefighters stood by to set up a landing zone if a helicopter was needed and Special Duty Responders provided lead-in and traffic control for the Red Feather Lakes ambulance.

**September 13, morning -- Incident #45** -- mutual aid to Red Feather Lakes VFD -- CLVFD firefighters responded to assist RFLVFD with a wildland fire south of Parvin Lake, where a campfire had escaped. Thankfully, the fire was caught early and extinguished before it had a chance to get out of control.

**September 18, morning -- Incident #46** -- mutual aid to Red Feather Lakes VFD -- CLVFD firefighters responded to assist RFLVFD with a wildland fire off of Deadman Road, where a campfire had escaped. Thankfully, the fire was caught early and extinguished before it had a chance to get out of control.

**September 18, morning -- Incident #47** -- medical call in Beaver Meadows - - CLVFD emergency responders provided patient assessment and care while firefighters set up a landing zone for Lifeline and Special Duty Responders provided traffic control for the landing zone and the Glacier View and UCHealth ambulances. All available personnel from Red Feather Lakes VFD, which usually responds ambulances to medical calls in Crystal Lakes were at the fire (incident 46), so Glacier View responded to help, according to our mutual aid agreements. Many thanks all around.

**September 25, evening -- Incident #48** -- mutual aid to Red Feather Lakes VFD -- CLVFD firefighters responded to assist RFLVFD with a wildland fire reported off of 73C near the slash depot. Red Feather determined it was the

campfire of someone camping illegally on private land and stood down Crystal Lakes responders while they dealt with the issue.

**October 1, afternoon -- Incident #49** -- smoke report in Pearl Creek area -- CLVFD firefighters responded to a report of smoke seen in the Pearl Creek area and tracked it to an illegal slash burn, which they extinguished.

**October 5, pre-dawn -- Incident #50** -- mutual aid to Glacier View Meadows VFD -- CLVFD firefighters responded to assist GVMVFD with a trailer fire that was threatening to turn into a wildland fire. CLVFD was able to send a water tender and two firefighters, who assisted in shuttling water to the firefighters on scene. The fire was extinguished without spreading beyond the trailer.

**October 18, afternoon -- Incident #51** -- medical call in Filing 11 -- CLVFD emergency responders provided patient assessment and care while Special Duty Responders established traffic control around the scene and led in the Red Feather Lakes ambulance.

**October 20, afternoon -- Incident #52** -- smoke report in Filing 11 -- CLVFD firefighters responded to a report of smoke seen from the 11th filing and appearing to originate in the 1st filing. This was tracked to some construction work, which was raising a lot of dust that looked like smoke, and all responders stood down.

**October 23, afternoon -- Incident #53** -- wildland fire at Creedmore Lakes -- CLVFD firefighters responded to a small wildland fire near the Creedmore Lakes camping area. Red Feather Lakes firefighters responded to assist and the fire was quickly extinguished.

**October 23, afternoon -- Incident #54** -- structure fire in Beaver Meadows -- Simultaneously with the above incident, CLVFD received a report of a cabin fire in the Beaver Meadows resort. Firefighters from both departments that were on their way to the Creedmore Lakes fire redirected to the fire in Beaver Meadows, which was thankfully contained quickly and prevented from spreading beyond the original structure. **October 24, evening -- Incident #55** -- medical call in Filing 2 -- CLVFD emergency responders provided patient assessment and care while Special Duty Responders established traffic control around the scene and led in the Red Feather Lakes ambulance.

**October 29, evening -- Incident #56** -- medical call in Elkridge area -- CLVFD emergency responders provided patient assessment and care while

firefighters established a landing zone for the Lifeline helicopter. Special Duty Responders set up traffic control around the landing zone and led in the Red Feather Lakes and UC Health ambulances.

**November 2, afternoon -- Incident #57** -- mutual aid to Red Feather VFD -- CLVFD emergency responders who were in the area assisted RFLVFD responders with a medical call at Red Feather fire station.

**November 5, night -- Incident #58** -- medical call in Filing 5 -- CLVFD emergency responders provided patient assessment and care while Special Duty Responders established traffic control around the scene and led in the Red Feather Lakes and UC Health ambulances.

**November 7, morning -- Incident #59** -- medical call in Filing 7 -- CLVFD emergency responders provided patient assessment and care while firefighters established a landing zone for the Lifeline helicopter. Special Duty Responders set up traffic control around the landing zone and led in the Red Feather Lakes and UC Health ambulances.

**November 22, morning -- Incident #60** -- medical call in Filing 7 -- CLVFD emergency responders provided patient assessment and care while firefighters established a landing zone for the Lifeline helicopter. Special Duty Responders set up traffic control around the landing zone and led in the Red Feather Lakes and UC Health ambulances.

**December 21, afternoon -- Incident #61** -- medical call in Filing 4 -- CLVFD emergency responders provided patient assessment and care while Special Duty Responders led in the Red Feather Lakes ambulance and firefighters stood by to assist as necessary.
