INCIDENT REPORTS FOR 2017

JANUARY

January 22, morning -- Incident #1 -- MVA/medical call on NCR 73C -- CLVFD emergency medical responders provided patient care and assessment while special duty responders provided lead-in for the Red Feather Lakes and PVH ambulances.

FEBRUARY

February 2, morning -- Incident #2 -- medical call in Filing 6 -- CLVFD emergency medical responders provided patient care and assessment while special duty responders provided lead-in for the Red Feather Lakes and PVH ambulances.

February 9, night -- Incident #3 -- possible powerline down south side of Crystal Lake -- CLVFD firefighters and special duty responders responded to search for a possible arcing or downed powerline on the south side of the big lake. The reporting party was on the north side of the lake and seeing flickering lights to the south. After some searching, responders determined that the lights seen were powerful security motion lights responding to nearby trees being whipped around in the high winds.

February 16, morning -- Incident #4 -- downed powerline in Filing 9 -- CLVFD firefighters responded to block traffic to the area until REA could arrive to fix a powerline down across a road.

February 25, afternoon -- Incident #5 -- motor vehicle accident in Filing 4 -- CLVFD emergency medical responders provided patient care and assessment while special duty responders provided traffic control around an accident that resulted in a car ending up upsidedown in Panhandle Creek near the airstrip.

MARCH

March 31, afternoon -- Incident #6 -- fire call in Beaver Meadows -- CLVFD firefighters responded to a smoke report in the Beaver Meadows area. An illegal/unpermitted slash pile burn was discovered and extinguished. Slash burns are permitted only on properties that are not members of the Road & Recreation Association and only with approved permits from the fire department and the county.

APRIL

April 14, all day -- Incident #7 -- forest service prescribed burn -- At the request of the forest service, CLVFD firefighters responded to assist them in monitoring the prescribed burn in the Red Feather/Creedmore Lakes area. Two shifts of firefighters spent a total of eleven hours on the fire.

MAY

- May 11, afternoon -- Incident #8 -- medical call in Filing 6 -- CLVFD emergency medical responders provided patient care and assessment while special duty responders provided lead-in for the Red Feather Lakes and PVH ambulances.
- May 13, afternoon -- Incident #9 -- medical call in Filing 3 -- CLVFD emergency medical responders provided patient care and assessment while special duty responders provided lead-in for the Red Feather Lakes and PVH ambulances.
- May 26, pre-dawn -- Incident #10 -- medical call in Filing 13 -- CLVFD emergency medical responders provided patient care and assessment while special duty responders provided lead-in for the Red Feather Lakes and PVH ambulances.
- May 30, pre-dawn -- Incident #11 -- medical call in Filing 13 -- CLVFD emergency medical responders provided patient care and assessment while special duty responders provided lead-in for the Red Feather Lakes and PVH ambulances.

JUNE

- **June 11, evening -- Incident #12** -- MVA on 73C -- CLVFD firefighters and emergency medical responders reported to the scene of a motor vehicle rollover accident near mile marker 3 on 73C. Medical responders provided patient care and assessment, and firefighters dealt with fluid leaks from the vehicle while special duty responders handled traffic control around the scene.
- **June 13, evening -- Incident #13** -- welfare check in Filing 6 -- CLVFD personnel turned out to check on a contractor whose family had not heard from him recently and determined that he was fine but unable to call out.
- **June 26, noon -- Incident #14** -- fire in Filing 6 -- CLVFD firefighters responded to extinguish a small fire burning near a shed. Neighbors attacked it with a fire extinguisher, keeping it from spreading until firefighters arrived to put it out.
- **June 27, night -- Incident #15** -- medical call in Filing 11 -- CLVFD emergency medical responders provided patient care and assessment while special duty responders provided lead-in for the Red Feather Lakes ambulance.

JULY

July 3, night -- Incident #16 -- smoke report in area of Eaton Reservoir -- CLVFD firefighters staged at the station upon request of Emergency Services to respond to smoke sighted from the Crystal Lakes/Red Feather area which was judged to be coming from near Eaton Reservoir to the northwest of Crystal Lakes. Other responding units from Livermore were able to determine that the smoke was drifting into the area from a fire in Wyoming and all units stood down.

- **July 3, night -- Incident #17** -- medical call in Filing 5 -- CLVFD emergency medical responders provided patient care and assessment while special duty responders provided lead-in for the Red Feather Lakes and Poudre Valley Hospital ambulances and handled traffic control for the landing zone established by firefighters for the MedEvac helicopter.
- **July 10, evening -- Incident #18** -- smoke report in Filing 15 -- CLVFD responders turned out in response to a report of smoke seen in the area of Mosquito/Shoshoni. Responders searched the area, expanding into Beaver Meadows as well, but were unable to locate the smoke that was reported.
- **July 14, afternoon -- Incident #19** -- medical call in Filing 8 -- CLVFD emergency medical responders provided patient care and assessment while special duty responders provided lead-in for the Red Feather Lakes and Poudre Valley Hospital ambulances.
- **July 21, evening -- Incident #2**0 -- assistance call in Filing 1 -- CLVFD personnel responded at a property owner's request to verify that a fire they had built was fully extinguished. They were concerned due to the fire restrictions in effect.
- **July 29, night -- Incident #22 (#21 was skipped by Dispatch)** -- smoke report on Black Mountain -- CLVFD responders turned out in response to a report of smoke seen on the flank of Black Mountain. Responders searched the area, from the base and south of Black Mountain on up, but were unable to locate the source of the smoke.
- **July 30, morning -- Incident #23** -- medical call in Filing 6 -- CLVFD emergency medical responders provided patient care and assessment while special duty responders provided lead-in for the Red Feather Lakes ambulance.
- **July 31, evening -- Incident #24** -- smoke report on Deadman Road -- CLVFD responders turned out in response to a report of smoke seen from the Beaver Meadows area and thought to be coming from near Deadman Road. Responders notified Red Feather that they would need to also send personnel along Deadman and moved to locations where they might be able to see the smoke report. Neither Crystal nor Red Feather responders were able to locate any smoke.

AUGUST

- **August 10, afternoon -- Incident #25** -- unattended campfire in Filing 11 -- CLVFD firefighters responded to extinguish a campfire left unattended and smoldering. Please be a good neighbor and make certain your campfire is entirely extinguished before leaving it!
- **August 12, early morning -- Incident #26** -- medical call in Filing 1 -- CLVFD emergency medical responders provided patient care and assessment while special duty responders provided lead-in for the Red Feather Lakes and Poudre Valley Hospital ambulances.
- **August 13, morning -- Incident #27** -- ATV accident in Filing 12 -- CLVFD emergency medical responders provided patient care and assessment while special duty responders provided lead-in for the Red Feather Lakes and PVH ambulances and firefighters established a landing zone for the Lifeline helicopter.

August 27, night -- Incident #28 -- mutual aid response to Glacier View VFD -- CLVFD sent a brush truck to assist Glacier View fire department in fighting a grass fire near Gate 1. CLVFD firefighters joined responders from a variety of agencies (including Red Feather Lakes, Livermore, and Larimer County Emergency Services) in this effort.

SEPTEMBER

September 1, noon -- Incident #30 (number 29 skipped by dispatch) -- smoke report south of Crystal Lakes -- CLVFD firefighters and SDRs responded to look for the source of smoke sighted south of Crystal Lakes near Deadman Road. CLVFD worked with RFLVFD to determine that the smoke was likely the haze coming in from out-of-state-fires.

September 1, evening -- Incident #31 -- unsafe campfire in Filing 11 -- CLVFD firefighters responded to a report of a potentially unsafe campfire spotted in Filing 11. Responders determined that the fire was of appropriate size in a firepit that met Crystal Lakes Road & Rec specifications and stood down.

September 1, evening -- Incident #32 -- unsafe campfire in Filing 9 -- CLVFD firefighters responded to a report of a potentially unsafe campfire spotted in Filing 9. The fire was determined to be far too large and in an unsafe firepit, and responders extinguished it as a matter of safety.

September 2, afternoon -- Incident #33 -- MVA on CR 73C -- CLVFD emergency medical responders provided patient care and assessment while special duty responders and firefighters provided traffic control around the scene of a motor vehicle accident on 73C.

September 4, afternoon -- Incident #34 -- reported explosion in Filing 9 -- CLVFD firefighters responded to a report of a potential explosion heard from a location in Filing 9 near CR 73C. Responders determined that the sound heard was the blowing of a trailer tire and stood down.

September 6, night -- Incident #35 -- medical call in Filing 9 -- CLVFD emergency medical responders provided patient care and assessment while special duty responders provided lead-in for Red Feather and PVH ambulances.

September 10, evening -- Incident #36 -- mutual aid request from Livermore VFD -- CLVFD firefighters responded to the station in response to a mutual aid call from Livermore. Responders determined that fire department manpower was not sufficient to send responders to this call while still maintaining appropriate coverage in Crystal Lakes and regretfully told Livermore that we could not send responders.

September 11, morning -- Incident #37 -- medical call in Filing 6 -- CLVFD emergency medical responders provided patient care and assessment while special duty responders provided lead-in for the Red Feather ambulance.

September 16, night -- Incident #39 (dispatch skipped #38) -- medical call in Filing 1 -- CLVFD responders staged at request of law enforcement to provide potential medical assistance to a person in need. Dispatch/law enforcement ultimately determined that the person was no longer in Crystal Lakes.

September 22, night -- Incident #40 -- assistance call in Filing 15 -- CLVFD personnel responded to assist a motorist with a stuck vehicle.

September 11, morning -- Incident #41 -- fire call on 73C -- CLVFD firefighters responded to a report of an unattended campfire on 73C between the Creedmore Lakes turnoff and Lost Lake. Despite driving this section of the road several times, responders were unable to locate a campfire.

September 30, evening -- Incident #42 -- medical call at Beaver Meadows -- CLVFD personnel responded to the report of a potential fall by someone wearing a medical alert device. Responders were able to make contact with the person and determine the activation of the device was an error.

OCTOBER

October 2, morning -- Incident #43 -- MVA on 73C -- CLVFD personnel responded to a vehicle and trailer that had jackknifed in the snow on North County Road 73C. No one was injured, but personnel were needed to handle traffic control around the incident until a tow truck could get the vehicle and trailer straightened out and back on the road.

October 16, pre-dawn -- Incident #44 -- mutual aid/fire call in Red Feather Lakes -- CLVFD firefighters responded to assist Red Feather Lakes VFD in fighting a structure fire in Red Feather Lakes.

October 28, morning -- Incident #45 -- medical call in Filing 7 -- CLVFD emergency medical responders provided patient care and assessment while special duty responders provided lead-in for the Red Feather Lakes ambulance and handled traffic control for the landing zone established by firefighters for the Lifeline helicopter.

October 29, afternoon -- Incident #46 -- medical call in Filing 7 -- CLVFD emergency medical responders provided patient care and assessment while special duty responders provided lead-in for the Red Feather Lakes ambulance.

NOVEMBER

November 16, noon -- Incident #47 -- fire call at Basecamp -- CLVFD firefighters responded to a tree that had fallen on a powerline and was sparking. Firefighters and SDRs stopped traffic around the area in case the powerline broke and/or fell and monitored the situation until PVREA arrived to fix the problem.

November 28, evening -- Incident #48 -- medical call in Filing 11 -- CLVFD emergency medical responders provided patient care and assessment while special duty responders provided lead-in for the Red Feather Lakes ambulance and handled traffic control for the landing zone established by firefighters for the Lifeline helicopter.

DECEMBER

December 16, evening -- Incident #49 -- medical call in Filing 8 -- CLVFD emergency responders provided patient assessment and care and lead-in for the Red Feather Lakes and PVH ambulances while firefighters established a landing zone for the Lifeline helicopter.

December 18, afternoon -- Incident #50 -- smoke alarm call in Filing 10 -- CLVFD firefighters responded to a report of a smoke alarm going off. Responders were quickly stood down when the property owner reported that it was a false alarm.
