## **INCIDENT REPORTS FOR 2019**

**January 17, noon -- Incident #1** -- medical call in Elkridge -- CLVFD emergency responders provided patient assessment and care while firefighers established a landing zone for the Lifeline helicopter and special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control to assist emergency vehicles to safely reach and leave the scene.

**January 25, afternoon -- Incident #2** -- medical call in Beaver Meadows -- CLVFD emergency responders provided patient assessment and care while special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control to assist emergency vehicles to safely reach and leave the scene.

**March 8, morning -- Incident #3** -- medical call in Filing 6 -- CLVFD emergency responders provided patient assessment and care while firefighters and special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control to assist emergency vehicles to safely reach and leave the scene.

**March 12, afternoon -- Incident #4** -- smoke alarm in Filing 10 -- CLVFD firefighters responded to check out a smoke alarm going off at a residence. Alarm was found to be false and responders stood down.

**March 28, evening -- Incident #5** -- smoke report west of Tami Road -- CLVFD firefighters responded to check out a report of smoke smelled and possible flames seen a distance west of Tami Road. Firefighters were unable to find a fire and stood down.

**April 22, afternoon -- Incident #6** -- carbon monoxide alarm in Filing 6 -- CLVFD firefighters responded to check out a carbon monoxide alarm going off at a residence. Alarm was found to be false and responders stood down.

**April 23, afternoon -- Incident #7** -- fire at Crystal Slash Pile -- CLVFD firefighters responded to assist Red Feather in extinguishing a fire at the slash pile, which rekindled several weeks after the controlled burn of the pile.

**May 9, afternoon -- Incident #8** -- medical call in Filing 9 -- CLVFD emergency responders provided patient assessment and care while firefighters and special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control to assist emergency vehicles to safely reach and leave the scene.

**May 17, morning -- Incident #9** -- medical call in Filing 7 -- CLVFD emergency responders provided patient assessment and care while firefighters and special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control to assist emergency vehicles to safely reach and leave the scene.

May 18, morning -- Incident #10 -- fire in Filing 12 -- CLVFD firefighters responded to a

- reported chimney fire. Upon arrival, they determined the fire had self-extinguished and, after checking for any sign of hot spots or other hazards, all responders stood down.
- May 20, afternoon -- Incident #11 -- medical call in Filing 14 -- CLVFD emergency responders provided patient assessment and care while firefighters and special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control to assist emergency vehicles to safely reach and leave the scene.
- May 23, afternoon -- Incident #12 -- medical call in Filing 12 -- CLVFD emergency responders provided patient assessment and care while firefighters and special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control to assist emergency vehicles to safely reach and leave the scene.
- May 24, afternoon -- Incident #13 -- medical call in Filing 6 -- CLVFD emergency responders provided patient assessment and care while firefighters and special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control to assist emergency vehicles to safely reach and leave the scene.
- May 26, night -- Incident #14 -- medical call in Filing 14 -- CLVFD emergency responders provided patient assessment and care while firefighters and special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control to assist emergency vehicles to safely reach and leave the scene.
- **June 1, noon -- Incident #15** -- medical call in Filing 12 -- CLVFD emergency responders provided patient assessment and care while firefighters and special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control to assist emergency vehicles to safely reach and leave the scene.
- **June 21, evening -- Incident #16** -- alarm near the fire station -- CLVFD firefighters responded to a report of an alarm going off near the fire station. Upon arrival, they discovered that it was an alarm on the Road & Rec Association's fuel tanks. After verifying it was a false alarm, they reset it and stood down.
- **June 27, evening -- Incident #17** -- medical call at Basecamp -- CLVFD emergency responders provided patient assessment and care while firefighters and special duty responders provided lead-in for the Red Feather Lakes ambulance and set up traffic control to assist emergency vehicles to safely reach and leave the scene.
- **June 28, afternoon -- Incident #18** -- medical call at the fire station -- CLVFD emergency responders provided patient assessment and care while firefighters and special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances, established a landing zone for the Lifeline helicopter, and set up traffic control to assist emergency vehicles to safely reach and leave the scene.

- **June 29, morning -- Incident #19** -- mutual aid response to Red Feather -- CLVFD personnel responded to assist RFLVFD by providing traffic control around a motor vehicle accident on 74E so responders could work safely.
- **July 2, afternoon -- Incident #20** -- medical call at the fire station -- CLVFD emergency responders provided patient assessment and care while firefighters and special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control to assist emergency vehicles to safely reach and leave the scene.
- **July 2, evening -- Incident #21** -- medical call in Filing 11 -- CLVFD emergency responders provided patient assessment and care while firefighters and special duty responders provided lead-in for the Red Feather Lakes ambulance and set up traffic control to assist emergency vehicles to safely reach and leave the scene.
- **July 3, morning -- Incident #22** -- mutual aid response to Poudre Canyon -- CLVFD personnel responded to a request to assist Poudre Canyon with extrication in a motor vehicle accident. While CLVFD responders were preparing to leave the station, firefighters on scene determined that no additional assistance was necessary and all responders stood down.
- **July 17, evening -- Incident #23** -- alarm in Filing 11 -- CLVFD firefighters responded to a report of a smoke alarm going off at a house in the 11th Filing. Responders walked around the house, from which no alarms were audible. Seeing no signs of a fire, all responders stood down.
- **July 20, noon -- Incident #24** -- medical call at the fire station -- CLVFD emergency responders provided patient assessment and care to an injured party who was brought to the fire station, while firefighters and special duty responders set up a landing zone for the Lifeline helicopter, provided lead-in for the Red Feather Lakes and UC Health ambulances, and set up traffic control to assist emergency vehicles to safely reach and leave the scene.
- **July 20, noon -- Incident #25** -- medical call at the fire station -- CLVFD emergency responders provided patient assessment and care to a patient who was brought to the fire station, while firefighters and special duty responders set up a landing zone for the Lifeline helicopter, provided lead-in for the Red Feather Lakes and UC Health ambulances, and set up traffic control to assist emergency vehicles to safely reach and leave the scene.
- **July 26, afternoon -- Incident #26** -- medical call in Filing 6 -- CLVFD emergency responders provided patient assessment and care to an injured party who was brought to the fire station, while firefighters and special duty responders provided lead-in for the Red Feather Lakes ambulances and set up traffic control to assist emergency vehicles to safely reach and leave the scene.
- **July 26, evening -- Incident #27** -- motor vehicle accident on 73C -- CLVFD personnel responded to a rollover accident on 73C. Firefighters stabilized and secured the vehicle to make it safe to work around. Emergency responders provided patient assessment and

care, while special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances, and set up traffic control to keep responders on the scene safe and assist emergency vehicles to safely reach and leave the scene.

**July 29, night -- Incident #28 -- medical call in Filing 8** -- CLVFD emergency responders provided patient assessment and care, while firefighters and special duty responders set up a landing zone for the Lifeline helicopter, provided lead-in for the Red Feather Lakes and UC Health ambulances, and set up traffic control to assist emergency vehicles to safely reach and leave the scene.

**August 18, noon -- Incident #29** -- mutual aid response to US Forest Service -- CLVFD personnel responded to a request to assist USFS with a fire from a downed powerline on Killpecker Trail. While CLVFD responders were preparing to leave the station, firefighters on scene determined that no additional assistance was necessary and all responders stood down.

**August 19, noon -- Incident #30** -- medical call in Filing 12 -- CLVFD emergency responders provided patient assessment and care, while firefighters and special duty responders provided lead-in for the Red Feather Lakes ambulance.

**August 22, pre-dawn -- Incident #31** -- mutual aid response to Red Feather structure fire -- CLVFD firefighters responded to assist Red Feather VFD with a structure fire. Firefighters were able to contain the fire to a single room and stood down once it was extinguished.

**August 31, afternoon -- Incident #32** -- medical call in Filing 13 -- CLVFD emergency responders provided patient assessment and care, while firefighters and special duty responders provided lead-in for the Red Feather Lakes ambulance.

**August 31, evening -- Incident #33** -- medical call at Potbelly Restaurant -- CLVFD personnel were initial responders to a medical call at the Potbelly due to being on scene when the call came in. They handed the call off to Red Feather Lakes VFD responders upon their arrival.

**August 32, night -- Incident #34** -- fire call in Filing 11 -- CLVFD firefighters responded to the report of the illegal campfire in Filing 11. Upon their arrival, they found that property owners had built a campfire in an unsafe fire ring. The owners extinguished their fire at firefighters' request and responders stood down.

**September 7, afternoon -- Incident #35** -- smoke report in Filing 10 -- CLVFD firefighters and special duty responders fanned out to find the source of smoke reported in the vicinity of Mosquito and Shoshoni. Responders tracked it to a property owner using a smoker and stood down.

**September 15, afternoon -- Incident #36** -- mutual aid response to McNay Fire -- At Glacier View VFD's request, CLVFD firefighters responded to assist with the McNay fire. Firefighters were on the fire until stood down later that day (by which time, additional resources had been called in by the county).

**September 17, morning -- Incident #37** -- mutual aid response to Dowdy Lake -- At Red Feather VFD's request, CLVFD emergency responders stood by at the station in case help or equipment was needed for Red Feather's response to a drowning. Ultimately, cold water rescue suits and gear were unnecessary.

**September 23, morning -- Incident #38** -- mutual aid fire response to Deadman Fire Tower -- CLVFD firefighters responded to assist Red Feather VFD with a reported wildland fire on Forest Road 170. Responders were asked to stage in Red Feather in case additional assistance was needed on the fire. Ultimately, no additional responders were necessary and CLVFD stood down.

**September 24, morning -- Incident #39** -- medical call in Filing 6 -- CLVFD emergency responders provided patient assessment and care, while firefighters and special duty responders provided lead-in for the Red Feather Lakes ambulance.

**September 26, afternoon -- Incident #40** -- mutual aid response to MVA on 74E -- CLVFD emergency responders provided medical assistance and traffic control at a Red Feather VFD motor vehicle accident on County Road 74E.

**September 26, evening -- Incident #41** -- wildfire on 73C near Lost Lake -- CLVFD firefighters responded to the report of smoke and flames seen on 73C between the edge of Crystal Lakes and Lost Lake. Upon arrival, responders discovered the fire was a flare-up of the prescribed burn being done by the forest service in the area. Forest service personnel arrived at the scene soon after CLVFD responders and determined that all fire activity was within the prescribed burn's boundaries and no fire response was necessary.

**September 29, morning -- Incident #42** -- medical call in Filing 5 -- CLVFD emergency responders provided patient assessment and care, while firefighters and special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances.

**September 29, afternoon -- Incident #43** -- wildfire in Filing 1 -- CLVFD firefighters responded to a wildfire in the area of Delaware and Santa Clara Courts. The fire was burning uphill, being pushed by the wind, and responders called in additional support from Red Feather VFD, Glacier View VFD, the forest service, and Larimer County Emergency Services. In addition, a SEAT did two slurry drops and a helicopter dropped a dozen buckets of water on the fire. Responders protected a threatened house and garage, dug fireline around the fire, and extinguished flames in the interior of the fire, ultimately standing down that day at 7pm. Both CLVFD and forest service firefighters returned the next day to seek out and extinguish any remaining hotspots and verify that the fire had been fully extinguished. Thanks to quick work on the part of all responders, the fire was

kept substantially to the size it was when responders first arrived, being ultimately measured at 1.3 acres.

**October 16, morning -- Incident #44** -- medical call in Filing 12 -- CLVFD emergency responders provided patient assessment and care while firefighers established a landing zone for the Lifeline helicopter and special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control to assist emergency vehicles to safely reach and leave the scene.

**October 21, evening -- Incident #45** -- medical call in Filing 8 -- CLVFD emergency responders provided patient assessment and care while special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control to assist emergency vehicles to safely reach and leave the scene.

**October 22, morning -- Incident #47** -- smoke report in Filing 3 -- CLVFD firefighters responded to a report of smoke west of Filing 3. After some searching, responders determined that it was not the result of a wildfire or structure fire and stood down.

**October 28, morning -- Incident #48** -- mutual aid to Poudre Canyon -- CLVFD firefighters responded to Poudre Canyon VFD's request for assistance with a serious motor vehicle accident on Hwy 14. Responders assisted with extrication and cleanup for several hours, then stood down.

**October 29, evening -- Incident #49** -- medical call in Filing 8 -- CLVFD emergency responders provided patient assessment and care while special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control to assist emergency vehicles to safely reach and leave the scene.

**November 6, morning -- Incident #50** -- medical call in Filing 8 -- CLVFD emergency responders provided patient assessment and care while special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control to assist emergency vehicles to safely reach and leave the scene.

**November 17, afternoon -- Incident #51** -- medical call in Filing 7 -- CLVFD emergency responders provided patient assessment and care while firefighters established a landing zone for the Lifeline helicopter and special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control to assist emergency vehicles to safely reach and leave the scene.

**November 27, evening -- Incident #52** -- medical call in Filing 9 -- CLVFD emergency responders and firefighters responded to the scene while special duty responders provided lead-in for responders from other agencies.

**December 3, evening -- Incident #53** -- medical call in Filing 9 -- CLVFD emergency responders provided patient assessment and care while special duty responders provided lead-in for the Red Feather Lakes ambulance and set up traffic control to assist emergency vehicles to safely reach and leave the scene.

**December 7, morning -- Incident #54** -- smoke report SE of Caddo Road -- CLVFD firefighters responded to the report of smoke sighted some distance SE of Caddo Road. This was ultimately determined to be the forest service slash burn on Manhattan Road and all responders stood down.

**December 15, afternoon -- Incident #55** -- medical call in Filing 8 -- CLVFD emergency responders provided patient assessment and care while special duty responders provided lead-in for the Red Feather Lakes ambulance and set up traffic control to assist emergency vehicles to safely reach and leave the scene.

**December 16, evening -- Incident #56** -- medical call in Filing 8 -- CLVFD emergency responders provided patient assessment and special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control to assist emergency vehicles to safely reach and leave the scene.

**December 25, morning -- Incident #57** -- medical call at Beaver Meadows -- CLVFD emergency responders provided patient assessment and care while firefighters established a landing zone for the Lifeline helicopter and special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control to assist emergency vehicles to safely reach and leave the scene.

**December 27, afternoon -- Incident #58** -- medical call at Beaver Meadows -- CLVFD emergency responders provided patient assessment and care while firefighters established a landing zone for the Lifeline helicopter and special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control to assist emergency vehicles to safely reach and leave the scene.

**December 30, afternoon -- Incident #59** -- medical call in Pearl Creek -- CLVFD emergency responders provided patient assessment and care while firefighters established a landing zone for the Lifeline helicopter and special duty responders provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control to assist emergency vehicles to safely reach and leave the scene.
